

THE 2026 “IRVING OIL BLUE POINTS SWIPE TO WIN SWEEPSTAKES” OFFICIAL RULES

The "Irving Oil Blue Points Swipe to Win Sweepstakes" (the "Sweepstakes") is offered by Irving Oil Retail Sales Inc. ("Irving Oil") in Canada and is administered by WSP International Limited ("Administrators"). Irving Oil hereinafter will be referred to as the "Sweepstakes Sponsor". BMO Blue Rewards, Inc. is in no way connected to the management of the Sweepstakes.

NO PURCHASE NECESSARY TO PLAY. Making a purchase will not improve your chances of winning.

General Sweepstakes Information: The Sweepstakes is being played at approximately 298 participating Irving Oil locations that accept the Blue Rewards™ card in Canada in the provinces of New Brunswick (NB), Nova Scotia (NS), Prince Edward Island (PE) and Newfoundland and Labrador (NL) ("Participating Locations"). To enter, swipe your active physical Blue Rewards™ card (or AIR MILES® card, as previously branded) at a Participating Location to earn one (1) entry for every 20 litres of fuel purchased (any fuel type) to a maximum of five (5) entries in a single transaction, or for every \$20 spent in-store after tax on convenience store products, automotive products, car washes and/or truck washes, to a maximum of five (5) entries in a single transaction. Maximum of ten (10) entries per person per day. Active Hometown Rewards members will receive two (2) times the entries otherwise awarded, for a maximum of ten (10) entries in a single transaction and twenty (20) entries per Hometown Rewards member per day. NO PURCHASE NECESSARY: You can obtain one (1) no purchase entry without making a purchase by sending 3" x 5" cards legibly printed together with your name, your Blue Rewards™ Member number, indicate if you are a Hometown Rewards Member, and your phone number to "Irving Oil Blue Points Swipe to Win Sweepstakes No Purchase Request", P.O. Box 3009 M.I.P., Markham, ON, L3R 6G4. Requests must be received by August 4, 2026. Each eligible no purchase request will receive five (5) Sweepstakes entries. Limit of one (1) request per outer mailing envelope and a maximum of two (2) requests per day during the Sweepstakes Period (see Rule 1 below), for a maximum of ten (10) no purchase entries per day. Active Hometown Rewards members will receive two (2) times the entries otherwise awarded for each eligible no purchase request, for a maximum of twenty (20) no purchase entries per day. Each request must be submitted in a separate outer mailing envelope. No mechanically reproduced or computer-generated requests allowed. Your no purchase entries will be automatically issued upon receipt of the no purchase request.

You must have an active Blue Rewards™ card to play and be eligible to win prizes in the Sweepstakes. If you do not have a Blue Rewards™ card, you can enroll in the Blue Rewards Program online at www.bluerewards.ca. By enrolling to become a Blue Rewards Member, you agree to be bound by the terms and conditions of the Blue Rewards Program as amended from time to time. There is no purchase or fee required to sign up for a Blue Rewards™ card. Please allow up to seven (7) days from the day that you sign up for your Blue Rewards™ card to be eligible to receive Sweepstakes entries. For the purpose of these Official Rules, the entrant is the individual in whose name the Blue Rewards™ Member number has been established, and this is the person to whom a prize will be awarded if they are selected and declared a winner. 1) SWEEPSTAKES DATES: The Sweepstakes begins at 12:00:01 AM, Eastern Time ("ET") on June 2, 2026 (the "Sweepstakes Start Date"). The Sweepstakes is scheduled to end at 11:59:59 PM ET on August 4, 2026 (the "scheduled Sweepstakes End Date"). The period between the Sweepstakes Start Date and the scheduled Sweepstakes End Date is known as the "Sweepstakes Period". Certain components of the Sweepstakes will end on different dates, as indicated elsewhere in these rules.

2) WHO CAN PLAY: The Sweepstakes is open to all legal residents of the provinces of NB, NS, PE and NL who have reached the age of majority, as of Sweepstakes Start Date, in the province in which they reside. Employees of Sweepstakes Sponsor, front line store employees of the Participating Locations, their respective parent companies, affiliates, subsidiaries, distributors, sales representatives, advertising and promotion agencies, agents, any participating prize sponsors, BMO Blue Rewards, Inc., or any entity that Sweepstakes Sponsor contracts with specific to this Sweepstakes, Sweepstakes administrators, website developers, auditing or legal firms and any other entity engaged in the specific production, administration, or execution of the Sweepstakes, and all their employees, officers, and directors, and members of their immediate families (defined, for these purposes as any persons with whom are domiciled (whether related or not)), are not eligible to participate in the Sweepstakes or win a prize. Sweepstakes Sponsor will make the final determination as to whether entrants are eligible to take part in the Sweepstakes.

3) PRIZES: Daily Prizes: One (1) daily prize of 50,000 Blue Points will be awarded each day during the Sweepstakes Period (64 daily prizes total). Grand Prize: One (1) Grand Prize of 5,000,000 Blue Points will be awarded. The ARV of all Blue Points prizes depends on the chosen method of redemption and available Reward options at the time of redemption. For example, 1,500 Blue Points can be used in-store for \$10 towards purchases at participating Blue Rewards Partners or used online for e-gift cards for \$10 worth of value at participating Partners. If redeemed for flights, value depends on destination chosen, date of travel and use of multiple

carriers or suppliers. Winner must pay applicable taxes, related transportation fees, governmental levies, excess baggage and other non-ticket costs. The value of Blue Points used for non-flight Reward options depends on Reward options in effect at the time of redemption. Blue Points prize is subject to the Terms and Conditions of the Blue Rewards Program as amended from time to time. Blue Points prize is not transferable or convertible to cash and must be accepted as awarded. Blue Points prize will be posted directly into the Blue Rewards Member account of the confirmed winner approximately six (6) to eight (8) weeks after completing the Winner Release Form (see Rule 4, Notification and Redemption, below). Odds of winning a Daily Prize or the Grand Prize depend on the total number of eligible entries received. All non-winning entries will roll over into subsequent Daily Prize drawings and the Grand Prize drawing. Random drawings will be held at the offices of the Administrators in Markham, Ontario on the day of the drawing or next business day, following the schedule below, from among all eligible entries received prior to the drawing (excluding winning entries from previous daily drawings). Prizes are nontransferable and no substitutions, in part or in whole, is allowed except as specified herein.

4) NOTIFICATION AND REDEMPTION: If you have been selected as a potential winner in any of the Sweepstakes’ drawings described above, the Sweepstakes Sponsor or Administrators will notify you via email and/or phone.
